

1. OBJECTIVE

- 1. To ensure that Hostel admissions are done as per GIT Hostel rules.
- 2. To ensure that Hostel admissions take place in correct manner and only eligible students take hostel admissions.
- 3. To facilitate the hostel admissions of the students willing to join Hostel only for Exam period.
- 4. To decide the policy of Issuing Rector Certificate for the students for office use.
- 5. To ensure that students complete admission formalities within schedule, with minimum time spent in queue and without fuss.

2. SCOPE

- 1. Students eligible to get admission to First Year and Direct Second Year in GIT.
- Students eligible to get admission to Second Year, Third Year and Final Year Engineering based on earlier year results and discipline maintained at hostel in previous year.
- 3. Students, who have applied for revaluation.
- 4. Dropper students are not eligible for hostel admission.

3. RESPONSIBILITY

- 1. Accounts Officer: To ensure that correct tables of fees chargeable to students are prepared depending on Hostel room category.
- 2. Hostel Warden: To ensure that only eligible students are admitted in hostel. To ensure that hostel fees paid by the student is equal to hostel room category.
- 3. Assistant Hostel Warden: To help the hostel warden to ensure that only eligible students are to be admitted in hostel.
- 4. Security: To check attendance of every student daily between 9.00.p.m and 10.00.pm.
 - To check in/out gate form of the students while coming in & out (over written, gate passes not signed by warden/class teacher/HOD and not be entertained by security on gate).
 - Late comers are to be reported to HOD and warden.
 - Restrict the students from late night (after 9.00.pm for Boys and after 7.30.pm for girls) roaming.
 - To stop the shouting of student and misbehaving with other students.

4. CROSS REFERENCE

Hostel Admission to Regular students

 Hostel Admission Schedule will be displayed at the end of the previous academic year.

2. Student have to contact warden and provisionally to book their seats according to room type i.e. 4 seated, 3 seated, 2 seated and 2 seated attached toilet bathroom.

- 3. Students seeking admission will have to purchase hostel admission form & obtain pay-in-slip from cash counter according to room type. Make payment of total fees in Saraswat Bank, obtain receipt of payment from the bank, submit bank receipt at GIT Cash Counter and obtain payment receipt from GIT Cashier.
- 4. Newly admitted student have to pay mess deposit in Saraswat bank.
- 5. Then the student has to submit duly filled admission form to hostel warden with required attachments.
- 6. Hostel warden will then allot the room to the student.

Provisional Admission

- The students, who are not eligible for admission as regular students due ATKT rules of University of Mumbai, but wish to attend classes, have to take provisional hostel admission. Provisional admission will be subject to pending revaluation application.
- Such students will have follow hostel admission procedure as above.
- 3. In case of positive revaluation result, student can continue his/her admission.
- 4. After revaluation result if the student is not eligible to continue the term in that academic year, then his/her hostel admission will be cancelled and his/her hostel fees will be refunded proportionately considering calendar month.

Hostel Admission for Exam period

- 1. Those student who want to take hostel admission only during exam period, have to obtain NOC from concerned hostel Warden & Registrar.
- 2. Such students will follow the admission procedure as above.

Hostel Mess:

- 1. Every student will have to pay mess charges right at the beginning of the month (i.e 1st week of the month) to the mess contractor.
- 2. Students are supposed to enjoy the food in their respective messes only.
- Mess defaulter will not be allowed to stay in the hostel.




